1. On December 10, 2008, the Official Committee of Unsecured Creditors (the "Committee") filed the *Interim Fee Application Request of Akin Gump Strauss Hauer & Feld LLP ("Akin Gump"), Co-Counsel for the Official Committee of Unsecured Creditors, for Interim Allowance of Compensation and for the Reimbursement of Expenses for Services Rendered During the Period from August 13, 2008 through October 31, 2008* (Docket No. 837) (the "Application").
2. On January 20, 2009, a hearing was held regarding the Application. At the hearing, Akin Gump agreed to a reduction of \$158.34 in expenses.
3. On January 21, 2009, the Court entered the *Omnibus Order on Interim (Quarterly) Fee Applications* (Docket No. 1038) (the "Omnibus Fee Order"), approving the fees and reduced expenses requested by Akin Gump in the Application.

4. The Omnibus Fee Order includes the correct requested fee amount of \$1,176,894.25 and total approved amount of \$1,207,900.30, but an incorrect amount of \$30,006.05 is listed for the requested expenses. The correct amount of requested expenses is \$31,006.05.



**ORDER CONCERNING FIRST INTERIM (QUARTERLY) FEE
APPLICATION OF AKIN GUMP STRAUSS HAUER & FELD LLP**

Upon consideration of the first interim fee application (the "Application") filed by Akin Gump Strauss Hauer & Feld LLP ("Akin Gump"); and a hearing having been held on the Application on January 20, 2009 and Akin Gump having agreed at such hearing to reduce its expense request by \$158.34; and the Omnibus Order on Interim (Quarterly) Fee Applications (the "Omnibus Order") having been entered on January 21, 2009 allowing Akin Gump's fees in the amount of \$1,176,894.25, expenses in the amount of \$30,006.05 and the total approved amount of \$1,207,900.30; and the correct amount of the requested expenses, as reduced by \$158.34, sought by Akin Gump is \$31,006.05, even though the total approved amount of \$1,207,900.30 set forth in the Omnibus Order is correct; and after due deliberation thereon; and good and sufficient cause appearing therefor; it is hereby

ORDERED, that the Omnibus Order is amended with respect to Akin Gump's expenses which are approved on interim basis in the amount of \$31,006.05 , subject to Akin Gump's filing of a final fee application, but Akin Gump's requested fees and total approved amount remain unchanged; and it is further
